

# SUBSIDY PROGRAM APPLICATION

## **SECTION 1: What is a City of Abbotsford Subsidy?**

Full time Abbotsford residents who experience financial barriers to participate in recreation opportunities may apply for the City of Abbotsford Subsidy program (a financial support that offers a fee reduction) which provides admission to any City of Abbotsford indoor facility and a discount for specific programs (as approved by City Council). Please note this process will assess your income eligibility, and can take up to two (2) weeks to process upon submission. Program is valid from **May 1, 2024 - April 30, 2025**.

## **SECTION 2: How do I apply?**

- Submit copies of documents listed in **SECTION 3**
- Confirm your net family/household income after tax is lower than the cut off in **SECTION 4**
- Complete the application form and details for all residents in your household in **SECTION 5**
- Submit this application form at Abbotsford City Hall Parks, Recreation & Culture office, 32315 South Fraser Way, 3rd floor. Our office is open Monday to Friday 8:30 am to 4:30 pm. We are closed all statutory holidays.

**For confidential reasons, we do NOT accept FAXED or E-MAILED applications.**
