<b>SECTION B - Terms of Bulk Water Fill Station</b>	
<p>I understand and agree that I am fully responsible for the safe and proper use of the Bulk Water Fill Station, and that I am expected to read and comply with the operating instructions and directions provided at the Bulk Water Fill Station. I understand the PIN supplied is unique to me and that I will be responsible for all water used by that PIN.</p> <p>I further agree that I will be billed monthly based on the actual water used at the current cubic meter rate in the Waterworks Rates and Regulation Bylaw or as amended. Failure to keep the account in good standing will result in termination of this permit.</p> <p>Business/Contractors: I further agree that that each tank truck or vehicle water tank that is used for the transport of any and all potable water obtained at the City of Abbotsford Bulk Water Fill Station that is intended for domestic purposes shall have an operating permit issued by Fraser Health as described in the Fraser Health Document "Guideline for Bulk Water Hauling". It is agreed that the use of the water is intended to be used within the bounds of the City of Abbotsford and District of Mission and that at any time without warning the City of Abbotsford can shut down the Bulk Water Fill Station.</p> <p>Residential: I further agree that all bulk water shall be transported in an appropriate tank suitable for potable water and shall be in a sanitary condition for which I am responsible for. Furthermore, I agree that all water taken shall be for my residential property within Abbotsford boundaries and not delivered or sold to any other property.</p> <p>I further agree to release, indemnify and save harmless the City of Abbotsford against and all claims, suits, actions, costs, expenses, losses and liabilities of whatsoever kind and by whomsoever brought against the City rising out of or in anyway due or relating to the granting to me this Bulk Water Fill Station Permit, or my compliance or non-compliance with the terms of this Permit.</p>
