

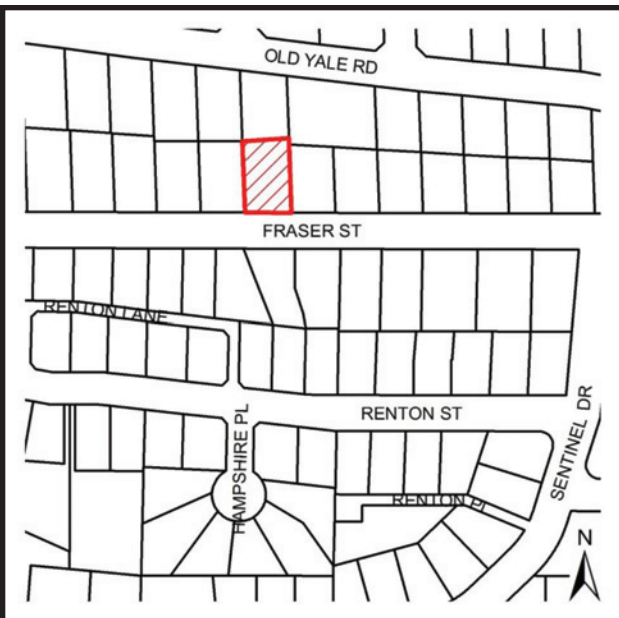
## Notice of Public Hearing

Abbotsford Council will hold a Public Hearing at 7:00 pm on December 18, 2017, in the Matsqui Centennial Auditorium, 32315 South Fraser Way, Abbotsford, B.C., under the provisions of the *Local Government Act* to consider the following bylaws. At the Public Hearing, all persons who believe their interest in property is affected by the proposed bylaws will be afforded a reasonable opportunity to be heard or to present written submissions respecting matters contained in the bylaws that are the subject of the hearing.

The following is a synopsis of the bylaws amending the Zoning Bylaw of the City of Abbotsford, and is not deemed to be an interpretation. 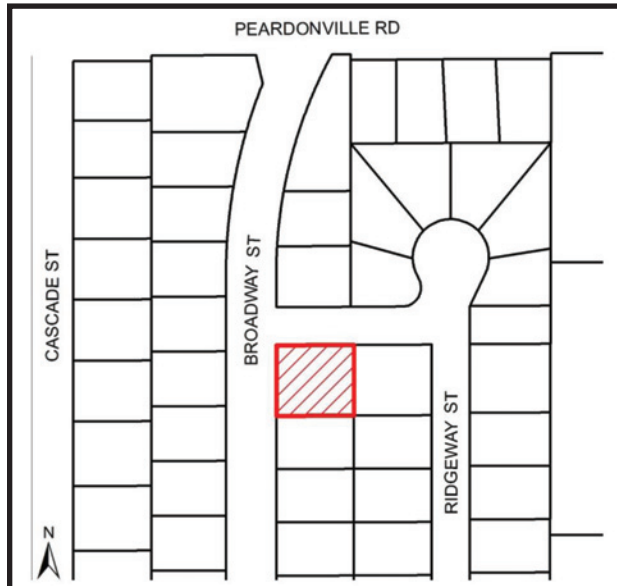
### ABBOTSFORD ZONING AMENDMENT BYLAW BYLAW NO. 2766-2017



**SUBJECT LAND:** 34265 Fraser Street  
**CURRENT ZONING:** Urban Residential Zone (RS3)  
**PROPOSED ZONING:** Comprehensive Development Seventy Five Zone (N75)  
**PURPOSE:** If Bylaw No. 2766-2017 is adopted, the applicant proposes to develop a two lot subdivision with secondary suites.

**SUBJECT LAND:** 32552 Ridgeway Street  
**CURRENT ZONING:** Urban Residential Zone (RS3)  
**PROPOSED ZONING:** Comprehensive Development Seventy Five Zone (N75)  
**PURPOSE:** If Bylaw No. 2762-2017 is adopted, a new Comprehensive Development Seventy Five Zone (N75) would be created. If Bylaw No. 2765-2017 is adopted, the applicant proposes to rezone the subject property from Urban Residential Zone (RS3) to Comprehensive Development Seventy Five Zone (N75) to facilitate a three lot subdivision.

## Utility Rate Increase

City Council approved a 3.75% utility rate increase on November 6, 2017. Effective January 1, 2018, Residential/Commercial/Institutional water rate will be \$1.24/m<sup>3</sup> and sewer rate will be \$1.04/m<sup>3</sup>. Additionally, Industrial/Agricultural water rate will be \$1.12/m<sup>3</sup> and sewer rate will be \$0.94/m<sup>3</sup>.
