
Notice of Public Hearing





SUBJECT LAND: **CURRENT LAND USE REGULATION:** PURPOSE:

2077 Oakridge Crescent

Land Use Contract No. 13

If Bylaw No. 2991-2019 is adopted, Land Use Contract No. 13 would be discharged from the Certificate of Title of the subject land. The current underlying Urban Residential Hybrid Zone (RSH) would then control development and would permit the construction of a conventional single family dwelling.

ABBOTSFORD ZONING AMENDMENT BYLAW BYLAW NO. 3002-2019

DESCRIPTION:

City-Initiated Zoning Bylaw Text

Amendment

PURPOSE:

If Bylaw No. 3002-2019 is adopted, the text of the Zoning Bylaw would be amended to add a new definition for extreme weather shelters and to permit extreme weather shelters in all zones with the exception of agricultural lots. This would differentiate extreme weather shelters from emergency shelters while better aligning the Zoning Bylaw with the

provincial Assistance to Shelter Act.

CITY COUNCIL ADVISORY COMMITTEE APPOINTMENTS

AGRICULTURE ADVISORY COMMITTEE

The purpose of the Agriculture Advisory Committee is to advise City Council on agricultural issues. The Agriculture Advisory Committee will be a liaison and communication channel between the agricultural community and City Council, and will provide a forum where agriculture related issues can be discussed with other agencies, committees and interest groups.

Vacancies: four (4) members from the farming industry (i.e. berry, dairy, greenhouse, poultry, or other farming type); one (1) member from the Agriculture Committee of the Abbotsford Chamber of Commerce; one (1) member from the BC Agriculture Council; and two (2) members at large.

AWARDS AND RECOGNITION ADVISORY COMMITTEE

The purpose of the Awards and Recognition Advisory Committee is to review nominations and provide recommendations of the annual recipient of the Order of Abbotsford to Council, and to provide recommendations to Council for nominations for the Order of British Columbia and British Columbia Community Achievement Award.

Vacancies: one (1) from the Abbotsford Chamber of Commerce; one (1) member from the Abbotsford Community Foundation; one (1) member from the Fraser Valley Indo-Canadian Business Association; one (1) member from Archway Community Services; and two (2) members at large.

BUSINESS, INNOVATION AND PUBLIC AFFAIRS ADVISORY COMMITTEE

The purpose of the Business, Innovation and Public Affairs Advisory Committee is to be a liaison and communication channel between the community and City Council, particularly in areas including government relations, legislative affairs, economic development and innovation.

<u>Vacancies:</u> one (1) member from the University of the Fraser Valley (President or Provost, or their designate); one (1) member from the Abbotsford Chamber of Commerce; one (1) member from the Indo-Canadian Business Association; one (1) member from the BC Agriculture Council; one (1) member from the Urban Development Institute – Fraser Valley; one (1) member from the Canadian Manufacturers and Exporters – BC; one (1) member from the Abbotsford Airport Authority; one (1) member from the Abbotsford Downtown Business Association; one (1) member from the BC Technology Industry Association; and one (1) member from the Fraser Valley Real Estate Board.

COMMUNITY, CULTURE AND ENVIRONMENT ADVISORY COMMITTEE

The purpose of the Community, Culture and Environment Advisory Committee is to maintain an effective channel of communication between the community and Council, particularly in the areas of culture, recreation, environment and green strategies.

Vacancies: one (1) member from the University of the Fraser Valley; one (1) member from the heritage community; one (1) member from the environment community; one (1) member from the Abbotsford School District; one (1) member from the culture community; one (1) member from Sport Abbotsford; one (1) member from the Fraser Health Authority; and three (3) members at large.

DEVELOPMENT, TRANSPORTATION AND INFRASTRUCTURE ADVISORY COMMITTEE

The purpose of the Development, Transportation and Infrastructure Advisory Committee is to maintain an effective channel of communication between Council and the community on issues related to land use, transportation, infrastructure, heritage (as it relates to development), bylaw and policy development and master plans and strategies.

In addition, the Committee will review and provide recommendations regarding applications for funding under the City's Affordable Housing Opportunities Reserve Fund.

Vacancies: one (1) member from Abbotsford School District; one (1) member from ICBC Road Safety; two (2) members from the development industry; two (2) members from the consulting professionals industry (i.e. architect, engineer, or environment, etc.); one (1) member from the University of the Fraser Valley; one (1) member from the Abbotsford Chamber of Commerce; one (1) member from the heritage community; and one (1) member from the accessibility community.
