

## Notice of Public Hearing to consider an amendment to Abbotsford Zoning Bylaw, 2014

Abbotsford Council will hold a Public Hearing at 7:00 pm on April 20, 2020, in the Matsqui Centennial Auditorium, 32315 South Fraser Way, Abbotsford, B.C., under the provisions of the *Local Government Act* to consider the following bylaw. At the Public Hearing, all persons who believe their interest in property is affected by the proposed bylaw will be afforded a reasonable opportunity to be heard or to present written submissions respecting matters contained in the bylaw that is the subject of the hearing.

### ABBOTSFORD ZONING AMENDMENT BYLAW BYLAW NO. 3003-2020



**SUBJECT LANDS:** 2405, 2413, 2427 and Lot 12 Crescent Way

**CURRENT ZONING:** Urban Residential Zone (RS3)

**PROPOSED ZONING:** Comprehensive Development One Hundred and One Zone (N101) and Park, Open Space and School Zone (P2)

**PURPOSE:** If Bylaw No. 3003-2020 is adopted, a new Comprehensive Development One Hundred and One Zone (N101) would be created and the subject lands would be rezoned to N101 and P2. The applicant proposes to build an 11 unit fee simple rowhouse development.
